RFI 2) RFP page "ii," item VI.A., Cover Letter, requests an SF330, and the instructions indicate the need for an SF330 for the primary firm, and that the Part IIs do count against our page limit. A full SF330 includes resumes, projects, background information, etc., information that is requested in items VI.C and IV.D, so we are wondering if you are only looking for SF330 Part IIs for our most key personnel on our team?

Answer: Yes, only Part II of the SF330 is required of key personnel on the team, that is, the "individuals who will have major contract responsibilities and/or provide unusual or unique expertise" as defined in the GSA Standard Form 330.

RFI 3) RFP page "ii," VI. Statement Contents, states that "The VI.D. supporting forms do not count toward the page limit. The documentation for RFQ Section 6E will not count toward the page limit." Can you please specify what "supporting forms" you are referring to?
