In accordance with Title 9-11-53.1 Code of Alabama 1975, any U.S. Veteran with a 20% or greater disability may purchase an annual saltwater fishing license at a reduced rate.

PRIVILEGE:

 Allows qualifying resident disabled military veteran to fish in saltwater jurisdiction of the state.

RESTRICTIONS:

 Applicant must show certification from Veteran's Administration showing a disability of 20% or more.

NOTE:

- All applicants must first present their driver's license(s).
- You are considered a Non-Resident IF you have an Alabama Driver's License or Non-Driver's ID and you possess a valid driver's license from another state.
- Applicants with multiple driver's license are not considered Alabama residents and must use their out-of-state driver's license to purchase non-resident licenses.
- License not required to fish from bank only in county of residence with ordinary hook and line (cane pole).




