Request for Qualifications for Preliminary Design, Environmental Compliance, and Project Administrative Services

Feasibility Study and Related Work for Enhancing Hydrologic Connectivity in Justin's Bay (Mobile Bay)

I. INTRODUCTION

Pursuant to §41-4-133 of the Code of Alabama, 1975, as amended, the ALABAMA DEPARTMENT OF CONSERVATION AND NATURAL RESOURCES (ADCNR) requests submissions of qualifications from professional services firms interested in providing a comprehensive feasibility study and related work associated with the Gulf Coast Ecosystem Restoration Council (RESTORE Council) Council-Selected Restoration Component Project, Enhancing Hydrologic Connectivity in Justin's Bay (Mobile Bay) (Federal Award GT3CP23AL0007) (Project), described here: https://www.restorethegulf.gov/sites/default/files/FPL3b AL Enhancing Hydrologic Connectivity in JustinsBay A ctivity Description.pdf.

ADCNR is requesting Statements of Qualifications for the Project to build upon a previous study of the Mobile Bay Causeway and hydrology conducted in 2015. The Project will support the primary RESTORE Comprehensive Plan goal to restore and conserve habitat through a planning effort that: 1) addresses any data gaps remaining from the 2015 study of the Mobile Bay Causeway and hydrology (Weston Solutions Inc. 2015); 2) evaluate the suggested restoration alternatives with a cost-logistics/feasibility frame of reference; and 3) move identified and prioritized restoration alternatives forward to a 30% preliminary engineering design.

For context, the construction of the Mobile Bay Causeway in 1927 resulted in a significant amount of dredge material placement over large portions of the Upper Mobile Bay marsh complex. At the time, filling of marsh was a preferred alternative to elevating the causeway and as a result, restrictions of hydrological interaction and connections between Mobile Bay and its Delta, including faunal migrations and natural food web interactions, have been truncated. Proposed Project activities will inform the restoration of the hydrological exchange necessary for coastal marsh and estuarine wetland habitats in the area to restore ecological integrity and ecosystem health. Project duration is expected to be 2 (two) years.

II. PROFESSIONAL SERVICES SCOPE OF WORK

ADCNR is seeking an engineering and design firm(s) to provide permitting, design, and environmental compliance services for the Enhancing Hydrologic Connectivity in Justin's Bay (Mobile Bay) project. ADCNR may award multiple contracts to multiple Offerors. The referenced project was approved for Bucket 2 funding on April 28, 2021 and is on the Funded Priority List 3b Funded Priorities List 3b Restore The Gulf

ADCNR is seeking a professional services firm to provide data collection and restoration planning services for the Project. As a part of this scope of services, the selected firm will:

A. Identify and address any data gaps remaining from the 2015 study of the Mobile Bay Causeway and hydrology (Weston Solutions Inc. 2015, link above) regarding the connectivity of Justin's Bay, indicated by the red box in

Figure.

- B. Develop suggested restoration concepts, with a cost-logistics/feasibility frame of reference (including an evaluation of the cost of utility modification), to 30% preliminary engineering design.
- C. Identify Environmental Compliance Requirements
- D. Provide Project Management to maintain communications with ADCNR regarding progress and budget.
- E. Execute related matters at ADCNR's request.

ADCNR anticipates entering into a contract with the successful firm for a two-year period, with two subsequent contract extensions (of two years, followed by one year) possible at ADCNR's discretion and as allowed by law. Anticipated services and tasks include, but are not limited to:

A. Planning: The selected firm will address any data gaps remaining from the 2015 ADCNR study. A detailed gap analysis study will provide guidance for any critical data pieces needing to be collected **before engineering and design takes place**. Data gap collection includes, but is not limited to, a fine resolution spatial delineation and extent of sediment contaminants in the restoration area; ecological impact studies; hydrodynamic modelling review; wave action modeling; water quality evaluation of the restoration area including potential changes to water temperature, salinity, and other parameters; and coordination with utility owners to optimize engineering designs.




Figure 1 Map of project area where Justin's Bay hydrological connection will be reestablished.

- **B.** Engineering & Design: The selected firm will utilize and apply standard engineering practices and Best Available Science to provide alternatives for enhancing hydrological connectivity between Justin's Bay, north of the Causeway, and Mobile Bay, south of the Causeway. Anticipated future conditions related to climate change, specifically sea level rise, will be considered throughout the design process. Current and future traffic conditions will also be considered throughout the project. Based on the alternatives presented by the selected firm, ADCNR will identify one or more hydrological enhancement option(s) to further develop 30% engineering and design plans. Alternatives should, at a minimum, consider box culverts only, bridges only, and combined bridge and box culverts options.
- C. Identification of Environmental Compliance Requirements: The selected firm will determine the permits and consultations required, as well as potential mitigation requirements. The selected firm will also determine potential impacts of environmental compliance on the alternative selected. The appropriate state/federal agencies will be engaged in order to understand permitting requirements for the respective design plans. Project design elements will be considered to maximize habitat quality as it relates to federally managed fish species. Further, the preliminary design will take into consideration best management practices to ensure marine mammals and threatened, or endangered species are not impacted. Additional activities may include testing of sediments, geotechnical investigations and other needs associated with site design environmental compliance.
- D. Project Management: Coordinate with ADCNR to ensure project remains on schedule and on budget.

Anticipated Project Budget: Approximately \$900,000.

Period of Performance: ADCNR anticipates entering into a contract with the successful firm(s) for a two-year period, subject to extensions at ADCNR's discretion and as allowed by law.

Partners: ADCNR will work and partner with the City of Spanish Fort, utility associations, and regulatory agencies to carry out Project objectives.

III. TERMS & CONDITIONS FOR RESTORE ACT:

Funding for this project is derived in whole or in part from funds received by ADCNR under the RESTORE ACT. Responders acknowledge and agree that, if selected, all work performed under the contract shall comply with and be bound by the following terms and conditions, which are expressly incorporated into the RFQ and any ensuing contract(s):

IV. ANTICIPATED TASKS AND DELIVERABLES

Task 1: Permit Procurement and Compliance

This task shall consist of identifying all federal and state agency environmental compliance (permitting and consultation) activities necessary to move the project to construction and communication with Baldwin County and Spanish Fort. The exact nature of the task activities is not currently known, but anticipated information that could be requested includes assessment data, submerged aquatic vegetation surveys, habitat assessments, and information

necessary to address comments received under public notice.

Deliverables include: documentation of consultation with municipal, county, state and federal regulatory authorities

Task 2: Compilation of Existing Data

The Contractor will gather and compile existing data and surveys to characterize the project site. This may include:

- Existing topographic/bathymetric surveys;
- Existing submerged aquatic vegetation surveys a/o wetlands delineations;
- Existing monitoring data;
- Existing wave, wind and climatological data;
- Existing Cultural/Historical Resources surveys and reports; and/or
- Other existing data and surveys that may inform the characterization the site.

Deliverables include: Compiled Surveys and Data.

Task 3: Data Collection Associated with Development of Preliminary Plans (Project Engineering and Design)

The Contractor will gather additional data and surveys as may be needed to further characterize the project site. This may include:

- Updated topographic/bathymetric surveys;
- Updated submerged aquatic vegetation surveys a/o wetlands delineations;
- Geotechnical orings and/or similar data; and/or
- Other existing data and surveys that may inform the characterization the site.

Deliverables include: Completed Surveys, Data and Reports

Task 4: Refinement of Restoration Alternatives

The Contractor will develop a range restoration alternatives for the project site. These restoration alternatives may include, but are not limited to:

- Placement of culverts
- Placement of bridge
- Combination of bridge and culverts

For each alternative, the Contractor shall develop of conceptual site plan, cross sections, order of magnitude construction estimate, and/or other information needed to inform modelling and evaluation of each alternative.

Deliverables include: Restoration Alternatives

Task 5: Develop Preliminary Plans (30% Project Engineering and Design)

This task shall consist of Engineering Services required for the preparation of a preliminary (30%) design. Activities may include survey work necessary to inform the design, as well as management of public engagement to solicit input for the design. Draft plans of alternatives shall be submitted for ADCNR review and comment, prior to moving forward with the 30% design.

Deliverables include: 30% Design plans

Task 6: Other related duties as requested by ADCNR.

Perform other tasks requested by ADCNR that are related to the Project.

VI. STATEMENT CONTENTS

Responses shall be limited to no more than a total of thirty (30) typed pages including: content pages, supporting appendices, and resumes. No text shall be smaller than a font size of 12. Covers, Tabs, and Table of Contents will not count toward the 30-page limit, nor will copies of the primary firm and employee licenses of key personnel. THE FORM Standard Form 330 IS REQUIRED FOR THE PRIMARY FIRM AND ITS KEY PERSONNEL ONLY. The SF330 Part II's count towards the 30-page limit but the instruction pages (1-8) do not. The VI.D. supporting forms do not count toward the page limit. The documentation for RFQ Section 6E will not count toward the page limit. The original Statement of Qualifications must be signed by an authorized representative of the entity. Submissions received after the deadline will not be considered. Facsimile or hand-delivered submittals will not be accepted.

Respondents are requested to document success with similar projects and experiences administering federal grant funded hydrologic restoration projects. Respondents must provide evidence of capacity to succeed with projects of similar scope and discuss how the firm achieved the goals of the past projects.

Contents of the Submittal Package in pdf form must include the following to be deemed responsive for evaluation:

A. Cover Letter

- a general statement distinguishing why the Respondent is the most suitable choice for this project.
- that the Project Team is committed to complete the project in a timely manner and will dedicate resources accordingly.
- The letter shall state 1) whether the firm is in arrears in the payment of any obligation due and owing to the State of Alabama, including tax payments and employee benefits, and that it shall not become so during the term of the agreement if selected; 2) a statement that the proposing Respondent will negotiate in good faith with ADCNR, and 3) a statement that the firm grants ADCNR a non-exclusive right to use, or cause others to use, the contents of its Statement, or any part thereof, for any purpose.
- The letter shall include the firm's Unique Entity ID (UEI) from SAM.gov.

B. Approach and Methodology

Respondents are requested to demonstrate their understanding of this project process by submitting an approach and methodology for completing the project along with a detailed schedule for project implementation. This narrative should articulate the Respondent's methods and approach, including:

- An outline of a project approach that meets the needs outlined in the Scope of Work section of this
 document.
- A schedule that is reasonable and considers all tasks described in the Project Scope of Work section
 of this document.
- A Methodology that is proven and acceptable.

C. Experience, Background, and Proposed Cost

Respondents are requested to document success with similar projects and experiences administering federal grant-funded hydrologic restoration planning and permitting projects, including the project description, project budget, scope of work, photographs (before and after), Owner's name and contact information, plus any other relevant information. Such as:

- documentation of methods that were used in the design of previous similar projects that achieved the goals of the project within a given budget,
- how original cost projections and engineer's opinions of cost provided realistic guidance for the proposed construction phase, and

All Statements accepted by ADCNR will be reviewed to determine whether they are responsive to the requisites of this RFQ. Statements that are determined by ADCNR to be non-responsive will not be further considered. ADCNR will evaluate Statements based on the project selection criteria below:

- Prior experience with state or federally funded programs (10 points)
- Professional Qualifications, including feasibility studies/alternatives analyses, design of hydrological connections, engineering, and environmental permitting – (35 points)
- Successful experience with design and administration of projects of similar scope (45 points)
- Capacity to perform design within a reasonable timeframe and within budget (10 points)

Documented comparable experience will be duly considered and evaluated.

VIII. FEDERAL CLAUSES:

Non-Commitment of Funds. Any contract related to this proposed project is subject to the availability of funds and/or the needs of the ADCNR and therefore the ADCNR, at its discretion, may or may not issue a final contract as a result of this RFQ.
