Hunting Regulations September 2024 – August 2025

#### **WHAT YOU NEED:**

- To hunt DEER or TURKEY: a Wildlife Management Area License and the applicable Resident or Non-Resident All Game Hunting License [for Alabama residents 16 through 64 years of age and for non-residents 16 years of age and older], are required.
- To hunt WATERFOWL: a Wildlife Management Area License, current HIP certification and valid State
  (ages 16 through 64) and Federal (ages 16 and over) Waterfowl Stamp, and applicable Resident or
  Non-Resident Small Game or All Game Hunting License [for Alabama residents 16 through 64 years of
  age and for non-residents 16 years of age and older], are required.
- To hunt small game except waterfowl: a Wildlife Heritage License OR applicable Resident or Non-Resident Small Game or All Game Hunting License [for Alabama residents 16 through 64 years of age and for non-residents 16 years of age and older], is required.
- **For ALL HUNTS:** a paper AREA Permit and a paper WMA daily permit are required UNLESS using the Outdoor Alabama WMA Check-In application to check in and out each hunt day.

#### **NOTES:**

- Freedom Hills WMA is located within the BUFFER ZONE OF THE CHRONIC WASTING DISEASE (CWD) MANAGEMENT ZONE.
- HUNTERS SHALL SUBMIT DEER HEADS FOR CWD TESTING FROM ALL DEER HARVESTED AT THE WMA CHECK STATION OR DROP-OFF SAMPLING FREEZER LOCATIONS OR A SCHEDULED DCNR MOBILE SAMPLING LOCATION.
- NO WHOLE DEER BODY PARTS SHALL BE TRANSPORTED OUTSIDE OF CWD MANAGEMENT
  ZONE. ONLY MEAT THAT HAS BEEN COMPLETELY DEBONED; CLEANED SKULL PLATES
  WITH ATTACHED ANTLERS, IF NO VISIBLE BRAIN OR SPINAL CORD TISSUE IS PRESENT;
  UNATTACHED BARE ANTLERS OR SHEDS; RAW CAPES, IF NO VISIBLE BRAIN OR SPINAL
  CORD TISSUE IS PRESENT; UPPER CANINE TEETH, IF NO ROOT STRUCTURE OF OTHER SOFT
  TISSUE IS PRESENT; AND FINISHED TAXIDERMY PRODUCTS OR TANNED HIDES CAN BE
  TRANSPORTED OUTSIDE OF THE CWD MANAGEMENT ZONE.
- Statewide antlered buck season bag limit applies to all WMAs, except for bonus buck as allowed.
- Youth hunters on youth deer and turkey hunts must be less than 16 years of age. Supervisors must be 21 years old or older, or a parent, and must be properly licensed. Youth must always remain within 30 feet of supervisors.
- Administrators of the hunt shall have the right to distribute the hunters and to inspect all vehicles or
  other equipment while on the WMA. The Department of Conservation and Natural Resources and landowners, who are making the hunting possible, hereby put each hunter on notice that they hunt at their
  own risk and the Department of Conservation and Natural Resources and such landowners shall not be
  responsible for any accidents or injuries that may occur.

ones A & B:	(Archery)	Oct. 15-Feb. 10 – Two deer a day, one unantlered deer and one antlered buck. No hunting on days of youth gun deer hunt. *No antler restrictions apply.
		Archery hunters must abide by all mandatory check station day requirements and gun deer hunt regulations/antler restrictions when hunting on days of gun deer hunts.
	(Youth)	<b>Nov. 16-17</b> – Two deer a day, one unantlered deer and one antlered buck. *No antler restrictions apply.
(Primi	itive Weapons)	<b>Nov. 18-22</b> – Two deer a day, one unantlered deer and one antlered buck. *No antler restrictions apply.
	(Gun)	<b>Nov. 28-Dec. 1, Dec. 12-15, Jan. 16-19</b> – Two deer a day, one unantlered deer and one antlered buck. *No antler restrictions apply.
Zone A:	(Gun)	Jan. 2-5 and Jan. 23-26 — One antlered buck a day. (Jan. 4 Bonus Buck Day, must be validated by WFF personnel at check station prior to leaving

leaving Area). \*Antlered buck restrictions apply.

\* To be legal for harvest, antlered bucks must have at least three (3) antler points (1 Inch or longer) on

**DATA COLLECTION:** All deer harvested must be submitted at check station for data collection on Fridays and Saturdays of gun hunts. The check station is open from 9:00am - 7:00pm. Additionally, the results of all hunts must be recorded using the Outdoor Alabama App or Daily Permit and submitted at kiosk at the conclusion of every hunt day.

TURKEY: (Youth) April 5 (Daylight until 1 p.m.) Gobblers only. Decoys allowed.

(Physically Disabled) April 7 (Daylight until 1 p.m.) Gobblers only. Decoys allowed.

(Regular) April 8-May 8 (Daylight until 1 p.m.) Gobblers only.

Decoys allowed Apr. 11-May 8.

**BAG LIMIT** – No more than 1 gobbler during the first 10 days of each season. No more than 2 gobblers total per hunter from Freedom Hills WMA.

WATERFOWL:	No Open Season
DOVE:	State season. (Opening day: 12:00 noon to sunset; remainder of season: ½ hour before sunrise to sunset). First two weeks of season: Saturdays and Wedne days only. Remainder of state season except, no hunting on days of youth, primitive weapons, or gun deer hunts. Bag limit: 15 per day.
RABBIT & SQUIRREL:	Sept. 14-March 2 – No hunting on days of youth, primitive weapons, or gun deer hunts. Fox squirrel season closed during February and March. Bag limit: 8 squirrels per day. 8 rabbits per day.
CROW:	<b>Sept. 1-March 2</b> – No hunting on days of youth, primitive weapons, or gun deer hunts <b>No bag limit.</b>
QUAIL:	<b>Nov. 2-Feb. 28.</b> – No hunting on days of youth, primitive weapons, or gun deer hunts. <b>Bag limit: 8 per day.</b>
WOODCOCK:	State season – No hunting on days of gun deer hunts. Bag limit: 3 per day.
SNIPE:	State season – No hunting on days of gun deer hunts. Bag limit: 8 per day.
RACCOON & OPOSSUM:	<b>Sept. 1-March 2</b> – Nighttime hours only. No hunting on nights preceding or nights of youth, primitive weapons, or gun deer hunts. <b>No bag limit.</b>
BOBCAT, COYOTE, OPOSSI	youth, primitive weapons, or gun deer hunts. <b>No bag limit.</b> UM, FERAL SWINE, RACCOON, FOX:

Open during any other scheduled WMA Hunting Season using weapons and ammunition

approved for those hunts. No dogs allowed. Daylight hours only. No bag limit.

FURBEARER TRAPPING: (Excluding feral swine) Oct. 26-Feb. 28 – Permits must be obtained from Area Biologist

### **IMPORTANT:**

All hunters must be familiar with WMA Regulation 220-2-.55. This regulation contains complete rules for hunting on this property. **In addition, it shall be unlawful:** 

\*Users must refer to WMA Regulation 220-2-.55 for the complete list of WMA regulations.

- To transport harvested deer or turkey from the WMA before reporting harvest in the Game Check System. Hunters must also submit such harvests at the WMA check station for data collection if hunt date is indicated as a mandatory check station day on the Outdoor Alabama WMA Application or AREA Permit. All other harvested game must be recorded on the Outdoor Alabama WMA Application or WMA Daily Permit.
- 2. To discharge firearms for target practice except on designated target ranges in accordance with listed rules during posted times and dates.
- 3. For any person, except authorized personnel, to operate any motor-driven vehicle behind locked gates, barricaded roads, or signs which prohibits vehicular traffic.
- 4. For any unauthorized person to possess and/or operate ANY UNLICENSED MOTOR DRIVEN VEHICLE on WMA, except when utilized for the express purpose of hunting, fishing, trapping, camping, or related activities; and when operated only on regularly used roads depicted on WMA map to be open to for public four-wheel motorized vehicle traffic.
- To damage or remove any artifacts, trees, firewood, plants, dirt, gravel, or sod without legal authorization.
- 6. To erect any permanent tree stand; install any screw-in style steps, spikes, or nails; or otherwise damage any tree.
- 7. For any unauthorized person to ride or possess horses on WMA except as detailed in Regulation 220-2-.55 (w) & (x).
